We are a contemporary art gallery and artist development organisation. Established by artists in 1984, our vision is to be one of the leading UK organisations for artists' development, building a compelling case for supporting artists, their work, their careers, and at every level.

We work with hundreds of artists every year, providing practice, career development, exhibition, and commission opportunities to those at all career stages, and from a diversity of backgrounds. We support more than 300 <u>Castlefield Gallery Associates</u> and a host of other creatives through person-centred development programmes. <u>Castlefield Gallery New Art Spaces</u> provide affordable making and project space in the North West, including on the high street.

We invest in and develop creative skills whilst facilitating national and international connection for creatives in the North West of England. Our national and international activities focus on artist exchange. We believe the North is a place for artists to live and work, a place from where they can carve out successful national and international careers.

Castlefield Gallery's public and participation programmes provoke new ways of thinking, bringing together artists, creatives, communities, and audiences to explore the art and issues of our time. We believe when artists and communities come together, they can help shape a better world.

Working from our galleries in Manchester, off-site, online and in the public realm, we create long-lasting impacts in our city region, North West and beyond. We are a home for artists and creatives. We are advocates for what we believe in. We believe in the power of new art and the essential role of artists in society.

Castlefield Gallery is a registered charity, supported by Arts Council England and Manchester City Council.

# **OUR REACH AND REPUTATION**

We're a small-scale organisation but one with international reputation.


For nearly 40 years we have nurtured the work and catalysed the careers of hundreds of artists. Castlefield Gallery 'alumni' have gone on to achieve brilliant things, including being winners and nominees for major prizes, exhibitors at major festivals, biennials, triennials and international presentations. Our alumni's works enter important private and public collections.

Castlefield Gallery has and continues to provide some of the first opportunities for artists living and working in Manchester to access formal, recognised exhibition opportunities. These often alternate and place exhibitions and works by national, international, and high-profile established professionals alongside regional artists at all career stages, including new graduates.

Castlefield Gallery has a long history of working in partnership and through dynamic collaborations, locally, regionally, nationally and internationally through exchanges, delegations and residencies. We extend our work across the city region and region, nationally from Glasgow to London, and internationally from the Czech Republic, Switzerland and Denmark to S. Korea, Hong Kong and more!

# **OVER THE LAST FIVE YEARS**

- The peak of our programme reach, including off-site, is estimated at 271,958 audiences, 3021 participants.
- Annually, Castlefield Gallery Associates hosts between 300 340 members.
- On average, digital content and products (including digital publications) have reached over 10,605 people per year.
- Castlefield Gallery Social Media platforms are home to communities of between 8000 17,500 people.
- Our audiences and participants live and work locally, regionally, nationally and internationally with a significant percentage based in the Manchester city region and North West of England.
- Whilst representing all age groups, including 65+years, Castlefield Gallery audiences and participants are dominated by 16-24 and 25-34years.

# **ACTIVITIES**

#### THE DETAIL OF WHAT WE DO

## 1. Support for artists

We focus on the power of artists' work over perceived 'art-world status,' supporting them when they need it most, sometimes over a period of years.

#### 2. Exhibitions, events, commissions and commissioning to collect

A fast-moving programme of exhibitions and events in our own gallery and partner spaces, public art commissions, online, delivered locally, nationally, and internationally.

#### 3. Public and participation programmes

That provoke new ways of thinking, bringing together artists, creatives, experts from across sectors, communities, and audiences to explore the art and issues of our time.

**4. A range of specialist and person-centred artist support programmes** Some of which are delivered through exchange with national and international partners.

#### **5. Castlefield Gallery Associates**

A 300-plus strong membership scheme that provides professional and practice development for artists, independent writers and curators.

#### **6. Castlefield Gallery New Art Spaces**

We take vacant retail and commercial units and turn them into low-cost work, project and production spaces for artists and creatives.

### 7. Advocacy and thought leadership

Collaborating with universities and cultural organisations, developing talent partnerships, pioneering community work, and making the case for the support of contemporary visual art and artists.

# **WHO WE ARE**

Castlefield Gallery is supported by a permanent staff team and Board of Trustees and Directors. We adopt a 'strength-based approach' to working with people. We operate a successful long-standing volunteer and placements programme. Many of the staff team were once Castlefield Gallery volunteers or placements, and some are now our Trustees. Driving talent development through our structure delivers on mission.

At times we also work with universities to support Collaborative Doctorate Awards, including research curators.

Artists and creatives form part of the make-up of Castlefield Gallery's volunteer group. It is important to us that previously or currently practicing artists are also represented within our staff team. Castlefield Gallery engages large numbers of freelancers on an annual basis, this group of workers are dominated by artists and creative freelancers.

We are deeply committed to social justice and work with those with lived experience of all forms of displacement.

# SUMMARY OF BOARD DIRECTOR & TRUSTEES ROLES

Members of the Board of Directors and Trustees have key responsibilities in the areas of strategic leadership, governance, development, and advocacy.

The Board supports the work of Castlefield Gallery and provides strategic leadership fully aligned with our purpose, mission, vision, and values. Members take an active role in the preparation and approval of our business, plan, annual budgets, major resource issues and policies. They safeguard Castlefield Gallery's financial stability, including approving the annual accounts. Members of the Board provide high level governance and overview. Within the context of effective controls, they enable risk to be assessed, at times taken, and effectively managed. The Board is responsible for ensuring that our obligations to our stakeholders and others are met.

The Board/Director & Artistic Director relationship is a partnership, and the appropriate involvement of the Board is both critical and expected. Genuine enthusiasm and commitment to Castlefield Gallery's purpose is key and at times members assist and advise on specific selected projects.

The Board provides advocacy and members are required to be effective ambassadors for Castlefield Gallery. Members need to participate and be present at governance meetings, in task and finish groups and/or sub-committees, and other events. Members need to bring a generosity of spirit in contributing their expertise, in activating their own contacts and relationships for the benefit of the charity and giving of their time.



# THE CHAIR'S ROLE

The Chair's role is to develop, manage and lead an effective Board of Directors & Trustees, whilst setting the right tone for the culture of the board. They will ensure company leadership is properly supported and the relationship with the organisation's leadership is positive and dynamic.

The Chair, with the trustees and charity's leadership, sets the strategic direction for the organisation, making sure the Board understands and fulfils all its responsibilities for Castlefield Gallery - a registered charity and company limited by guarantee. Ensuring that board structure best supports strategy, and its members have an appropriate mix of skills and experience to do this, is a key responsibility of the Chair.

As at organisational level, Castlefield Gallery's culture encourages a strengths-based approach and this approach should also be applied to members of the board in the interest of the charity. The role must enable all voices in the room to be genuinely heard while synthesising views and outlining the direction of travel. This is key to the Chair's role in securing decision making that involves all, and at times on difficult and complex matters where there may not be immediate consensus.

The management and development of relationships with Castlefield Gallery stakeholders is critical for our future and the Chair will play a major role in supporting this. The Castlefield Gallery Chair takes a leading role in the public representation of, and advocacy for the organisation. Vitally, our Chair will need to lead and embrace action, including in our own organisation, to confront inequality in the arts, cultural sector and beyond.

# THE CHAIR'S KEY RESPONSIBILITIES

# **LEADERSHIP**

- Provide leadership and direction to the Board, creating clear expectations in relation to purpose, mission, vision, and resources.
- Work collaboratively, with fellow members and gallery leadership, oversee development of long and short-term objectives and priorities that reflect our values and meet the needs of artists, communities, and stakeholders.
- Nurture 360 thinking when approaching charity decision making. As applicable provide wise counsel. Lead the board on monitoring and review of performance.

# **BOARD GOVERNANCE**

- With Board finance leads and charity leadership, ensure prudent financial management and approve the annual accounts, risk register and reserves policies.
- Lead discussion to approve the business plan and other key planning documents as prepared by the charity's leadership, and with support from the members.
- With the Board members and support from the organisation's leadership, regularly review composition and activities of task and finish and/or sub-committee groups.
- Take decisions in conjunction with the Board, between Board meetings where necessary, within parameters agreed with the Board.
- Arrange for another Board member to chair meetings in your absence, in the first instance with the Vice-Chair.


- Guide and ensure good governance, to ensure operation in accordance with Company and Charity Law and the organisation's own governing documents.
- Set, lead, and deliver effective quarterly meetings of the members that ensure the Board meets its duties and interacts with the charity's leadership as appropriate.
- With the members and charity's leadership, ensure Board papers are prepared and circulated in a timely manner whilst actively participating in Board discussions.
- Monitor any conflicts of interest as they arise, and ensure they are declared at board meetings.

# **COMMUNICATIONS & ADVOCACY**

- With the Board and organisation's leadership, build and enhance relationships with funders, current and potential partners, as well as stakeholders who may help to support the work of the charity.
- Act as ambassador and spokesperson for the charity, where appropriate and agreed with the Board members, to help raise the profile and grow the reputation of Castlefield Gallery.
- Make every effort to see work, attend events and encourage other Board members to do the same.

# BOARD AND LEADERSHIP MANAGEMENT AND DEVELOPMENT

- In the context of Castlefield Gallery's communities, ensure relevant diversity of representation within company leadership, Board membership and skills.
- With the Vice-Chair, advise, support and line manage the gallery's Director & Artistic Director.
- Ensure that the Board addresses governance matters in relation to its own structure, role, and relationship to management.
- Work with Directors & Trustees, and company leadership, to respond to any concerns arising from the Board, including on the role of the Board or regarding individual trustees.
- In consultation with the Vice-Chair, periodically consult with Board members on their roles, assess their performance and attendance at meetings and ensure an annual skills audit is completed.
- Work with the Board to ensure continuous development and renewal of Board membership and support the recruitment of new Board members in relation to the organisation's skills audit and commitments.



# WHO WE ARE LOOKING FOR

- The Chair will be committed to contemporary art and Castlefield Gallery's purpose, mission, vision, values, and beneficiaries.
- You will have a demonstrable commitment to equality, diversity, inclusion, equity, and willingness to take action to ensure the Board reflects the diversity of the people we work with and our wider communities.
- The Chair will need personal qualities of integrity, be willing to speak their mind whilst ensuring they are tactful, diplomatic, and make effective use of their soft power.
- You will have the ability to effectively steer the organisation and its governance through decision making leading whilst also operating as a member of a team, inspiring and empowering others to be proactive in their roles on the Board.
- The Chair will have an appetite for continuous development, be open to change and taking well managed risk, and have the ability to think creatively whilst also focus on practical issues.
- You will have good independent judgment, with a desire to work in the best interests of Castlefield Gallery, without regard to personal interest or benefit.
- You will be committed to impartiality and fairness. The Chair will be respectful of confidences.
- The Chair can come with knowledge resulting from a range of experiences and from any sector. However, they will usually have achieved a leadership role and/or have a senior successful track record in business or in the public, non-profit sectors, or equivalents, and be active in relevant, established, and diverse networks.

- You will have ambassadorial skills and an ability to cultivate relationships, influence, convene, facilitate, and build consensus among diverse individuals in the service of Castlefield Gallery. This will involve being a skilful communicator and listener.
- You will have the ability to work individually and collectively on behalf of Castlefield Gallery, and together build a high performing team of the Director & Artistic Director, Deputy Director, and Board, one driving strategic vision.
- The Chair should have a strong understanding of good governance, and in acceptance of the legal duties, responsibilities, and liabilities of the trusteeship of a charity, directorship of a company limited by guarantee.
- You will have a demonstrable understanding of the cultural, artistic, economic, social, and political context Castlefield Gallery operates in.
- The Chair will usually have broad knowledge and understanding of the range of funding – public and private as well, business development and income generation opportunities available to Castlefield Gallery. Ideally you will have relevant connections and reputation in this regard.
- Working collaboratively with Board members and the organisation's leadership as appropriate, you will be able to engage with and communicate sometimes complex information, including financial.
- You will be able to dedicate time and effort to supporting the gallery, and be willing to take a proactive role in the whole of the business.

# **ELIGIBILITY**

Our Chair is required to act reasonably and prudently in all matters relating to Castlefield Gallery and must always bear the interests of the gallery in mind.

You are prevented from acting as a trustee if you:

- Are disqualified or barred from acting as a trustee of this charity under the Safeguarding Vulnerable Groups Act 2006.
- Have an unspent conviction for an offence involving dishonesty or deception.
- Are disqualified from being a company director.
- Have previously been removed as a trustee by the Charity Commission or the High Court due to misconduct or mismanagement.
- Are currently declared bankrupt (or subject to bankruptcy restrictions or an interim order).
- Have an individual voluntary arrangement (IVA) to pay off debts with creditors.

Although selection as a Trustee is not a public appointment, the seven principles of public life as defined by the Nolan Commission (selflessness, integrity, objectivity, accountability, openness, honesty and leadership) are applicable to this role.

#### **CHAIR COMMITMENTS**

The charity's Chair (and Board members) serve a minimum three-year term. Following this initial term, they then become eligible for reappointment for additional terms. In addition to chairing the main Board meetings, the Chair can opt to attend any task and finish group or sub-committee meetings.

This role is voluntary, though reasonable expenses are reimbursed.

Approximate capacity needed is 20 - 24 days per annum. See estimate breakdown on the next page:

#### **EQUALITY MONITORING**
